Why Women, Gender, and Health?

- This approach requires the study of the health of people of all genders and gender identities throughout the life course, with gender, gender inequities, and biology understood as important and interacting determinants of well-being and disease.
- Also included are: the study of gender and gender inequities in relation to individuals' treatment by, and participation in, health and medical care systems; the physical, economic, and social conditions in which they live; and their ability to promote the health of their families, their communities, and themselves.
- Inherent in this definition is recognition of diversity and inequities among people of all genders in relation to racialized group, ethnicity, nationality, class, sexual orientation, and age, and that the protection of human rights is fundamental to health.

About WGH

The Working Group on Women, Gender, and Health (WGH) was founded in 1996, and in 2002, the school wide faculty approved the interdisciplinary concentration on WGH. The Working Group, comprised of faculty, staff, fellows, and students, meets monthly, and all are invited to attend. We take a pedagogical approach to planning events and teaching courses. The Working Group encourages students to become involved by participating in decisions for WGH and meeting others who share interests.

The Women, Gender, and Health Interdisciplinary Concentration creates an opportunity for students to engage with fellow students, staff, faculty, and speakers on topics related to gender and health

Events

WGH hosts and co-sponsors regular events, including in-person, hybrid, and virtual. Events happen monthly and generally feature a speaker/facilitator who introduces a gender-related health topic of interest, followed by a discussion applying a critical gender analysis. WGH also hosts monthly Working Group meetings.

Conference Stipends

WGH's conference stipends are open to all HSPH students to support attendance at conferences that have a gender analysis and health focus, whether or not the student is presenting. While priority is given to students who are presenting, a limited number of stipends are available for attendees. Awardees are expected to share key takeaways at a WGH Working Group meeting.

Students may receive up to one or two stipends over the course of their enrollment at Chan depending on the duration of their degree. Each stipend provides funding of **up to** US\$750 (domestic) or US\$1,000 (international) to support travel, accommodation, registration, and incidental costs. Stipends are competitive, with funding levels dependent on the number of applicants. Please visit our website for full details and application materials.

Concentration

All HSPH students are invited to complete the 10-credit WGH Concentration (details on next page) to gain proficiency in intersectional gender analysis for public health research, programs, and action. Fulfilling the concentration is distinct from, and in addition to, fulfilling degree and home department requirements.

†May count up to 2.5 credits towards the Women's Health and/or Gender Analysis component. If WGH 300 is taken with a non-WGH faculty member, approval must be granted before courses begin.

Concentration Requirements

- 1. 5 credits in any of the WGH core courses
- 2. Another 2.5 credits of WGH core courses OR gender analysis courses
- 3. 2.5 credits in any other courses listed (WGH core, gender analysis, or women's health content)

Students who complete concentration requirements receive a letter attesting to completion.

Note that the list of courses below is not comprehensive. Additional courses and independent studies with a gender analysis focus or women's health component (taken at Chan or at other Schools permitting cross-registration for HSPH students, e.g., other Harvard Schools and MIT) may also be used to fulfill the above requirements, pending approval.
